# THE SOUTH AFRICAN CANINE BREED REGISTRY

(Registration application for a registered breeder & kennel)

**1. WHAT IS A REGISTERED KENNEL NAME?**

It is a word that, upon application by a breeder, may be granted for a One-year period by the SACBR for sole use of that breeder in the naming of dogs as he/she may apply to register. The SACBR undertakes to exercise reasonable care in protecting such names for the use of individuals to whom they have been granted. A Certificate is issued and posted to the new member.

**2. WHO MAY BE GRANTED A REGISTERED KENNEL NAME?**

Any person in good standing with the SACBR may take application. It is the present policy of the Registry to restrict the granting of such names to persons whose record of breeding and registering dogs identifies the applicant as a serious breeder, whose activities are non-commercial, and who's past registration practices have been satisfactory to the SACBR and in conformity with its rules and regulations.

**3. DOES THE GRANTING OF A REGISTERED KENNEL NAME CONSTITUTE THE 'REGISTERING' OF THE APPLICANTS BREEDING ESTABLISHMENT OR KENNEL IN THE RECORDS OF THE SACBR?**

It does not. The SACBR does not register kennels, breeding establishments, dog dealerships, pet shops, training or grooming establishments. It simply records the fact that an individual, who is qualified under established policies, has been granted, for his or her use, a particular word that can be used in the name of a dog sought to be registered.

**4. WHAT KINDS OF WORDS MAY BE APPROVED AS A REGISTERED KENNEL NAME?**

A registered kennel name must be one or more hyphenated or un-hyphenated word(s) totaling not more than 20 letters. Unacceptable names would include but not necessarily be limited to conflicts, either phonetically or in spelling with: The name of a breed, SACBR Titles, names of major cities, countries, states, rivers, mountains, towns, schools, common family names, corporations or trade names as well as names of very famous and universally recognized persons, living or dead. Words commonly used by many different breeders in naming dogs will not be registered to one breeder.

**5. IF AN APPLICANT FOR A REGISTERED KENNEL NAME IS REJECTED, MAY THE APPLICANT, NEVERTHELESS, USE IT IN NAMING OF HIS/HER DOGS?**

In most cases, this can be done. If, however, the name applied for is rejected because of conflict with a name already registered, the word obviously cannot be used.

**6. REQUIREMENTS FOR A REGISTERED KENNEL NAME:**

The breeder has to own a minimum of 1 or more dogs of which none have been neutered or spayed. Each dog has to be SACBR-registered.

**7. ADDITIONAL INFORMATION:**

No more than two persons may apply for a registered kennel name. The present fee is **R300.00**. Please complete the information below and make payment at any Standard bank Branch in your area. The SACBR has no annual renewal fees presently (it may change if required by the registry).
